NOTICE OF HEARING

IT IS ALLEGED THAT:

- You have committed an act of professional misconduct as provided by subsection 51(1)(b.0.1) of the *Health Professions Procedural Code* of the *Nursing Act, 1991*, S.O. 1991, c. 32, in that, while registered as a Registered Nurse with the College of Nurses of Ontario, you failed to cooperate with the Quality Assurance Committee or any assessor appointed by that committee, and in particular, in or around 2021 – 2022, you failed to participate in a Quality Assurance assessment as directed by the Quality Assurance Committee, pursuant to an Order of the Discipline Committee dated October 9, 2020.
- 2. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code* of the *Nursing Act*, 1991, S.O. 1991, c. 32, as amended, and defined in subsection 1(21) of *Ontario Regulation 799/93*, in that, while registered as a Registered Nurse with the College of Nurses of Ontario, you failed to comply with an Order of the Discipline Committee, and in particular:
 - a. in or around 2020 2021, you failed attend two meetings with a Regulatory Expert, pursuant to an Order of the Discipline Committee dated October, 9, 2020; and/or
 - b. in or around 2021 2022, you failed to participate in a Quality Assurance assessment as directed by the Quality Assurance Committee, pursuant to an Order of the Discipline Committee dated October 9, 2020;
- 3. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code* of the *Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(19) of *Ontario Regulation 799/93*, in that, while registered as a Registered Nurse with the College of Nurses of Ontario, you contravened a provision of the Act, the

Regulated Health Professions Act, 1991 or the regulations under either of those Acts, and in particular, you contravened section 11 of the *Nursing Act, 1991*, when from on or about February 17, 2022 to March 17, 2022, you practised nursing while your certificate of registration was suspended and/or used the title registered nurse and/or nurse, or a variation thereof, and held yourself out as a person who is qualified to practise nursing in Ontario.

- 4. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code* of the *Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(37) of *Ontario Regulation 799/93*, in that you engaged in conduct or performed an act, relevant to the practice of nursing, that, having regard to all the circumstances, would reasonably be regarded by members of the profession as disgraceful, dishonourable or unprofessional, as follows:
 - a. in or around 2020 2021, you failed attend two meetings with a Regulatory Expert, pursuant to an Order of the Discipline Committee dated October, 9, 2020;
 - in or around 2021 2022, you failed to participate in a Quality Assurance assessment as directed by the Quality Assurance Committee, pursuant to an Order of the Discipline Committee dated October 9, 2020;
 - c. from on or about February 17, 2022 to March 17, 2022, you practised nursing while your certificate of registration was suspended and/or used the title registered nurse and/or nurse, or a variation thereof, and held yourself out as a person who is qualified to practise nursing in Ontario.

The allegations respecting professional misconduct on your part will be heard by a panel of the Discipline Committee of the College of Nurses of Ontario ("CNO"), pursuant to the *Nursing Act, 1991, S.O. 1991, c.32, as amended, and subsection 38(1) of the Health Professions Procedural Code, on July 15-16, 2024 at 0930 hours or as soon after that time as the hearing can be commenced, via electronic hearing by way of teleconference or videoconference.*

The details for participating in the electronic hearing will be provided to you by a Hearings Administrator. If you have not heard from a Hearings Administrator at least 48 hours in advance of the hearing, you should contact the Hearings Administration Team at: Admin-Business.Support-Hearings@cnomail.org to obtain the details for participating in the electronic hearing.

If you believe that holding an electronic hearing rather than an oral hearing is likely to cause you significant prejudice, please communicate in writing the basis for asserting such prejudice to the Hearings Administration Team at the email address listed above. To ensure the claim of prejudice can be considered by the Discipline Committee, any such concerns should be communicated to the Hearings Administration Team as soon as possible, and no later than 21 days in advance of the hearing.

Take notice that at least 48 hours before the electronic hearing is scheduled to commence, you must provide notice to the Hearings Administration Team, at the email address listed above, of the telephone number and email address where you can be reached for the electronic hearing.

If you fail to participate in the electronic hearing in person or by representative, the panel of the Discipline Committee may proceed in your absence and you are thereafter not entitled to any further notice of the proceedings.

Where the panel of the Discipline Committee finds a member has committed an act of professional misconduct, it may make an Order doing any one or more of the following:

- 1. directing the Registrar to revoke the member's certificate of registration;
- 2. directing the Registrar to suspend the member's certificate of registration for a specified period of time;
- 3. directing the Registrar to impose specified terms, conditions and limitations on the member's certificate of registration for a specified or indefinite period of time;
- 4. requiring the member to appear before the panel to be reprimanded;
- 5. requiring the member to pay a fine of not more than \$35,000.00 to the Minister of Finance;
- 6. requiring the member to reimburse CNO for funding provided for a program of therapy and counselling for a person if the act of professional misconduct was the sexual abuse of that person; and
- 7. requiring the member to post security acceptable to CNO to guarantee the payment of any amounts the member may be required to reimburse CNO for a program of

therapy and counselling for a person who was sexually abused by the member.

Furthermore, the panel may suspend the effect of its Order for a specified period of time and on specified conditions and where it makes an Order under paragraph 2 or 3 above, it may specify criteria to be satisfied for the removal of a suspension or the removal of terms, conditions and limitations imposed by the Order on the member's certificate of registration.

Where a panel of the Discipline Committee finds a member has committed an act of professional misconduct, it may make an Order requiring the member to pay all or part of the following costs and expenses:

- 1. CNO's legal costs and expenses;
- 2. CNO's costs and expenses incurred in investigating the matter; and
- 3. CNO's costs and expenses incurred in conducting the hearing.

CNO intends to introduce as business records, under section 35 of the *Evidence Act*, any writings or records that were made in the usual and ordinary course of business. Without limiting the generality of the foregoing, and where applicable, CNO intends to introduce as business records medical and hospital charts.
