NOTICE OF HEARING

IT IS ALLEGED THAT:

1. You have committed an act of professional misconduct as provided by subsection 51(1)(a) of the *Health Professions Procedural Code of the Nursing Act, 1991*, S.O. 1991, c. 32, as amended, in that while registered with the College of Nurses of Ontario as a Registered Practical Nurse, you were found guilty of an offence relevant to your suitability to practise, as follows:
 - a) on October 31, 2022, in the Ontario Court of Justice, you were found guilty of one count of theft under \$5,000.00, contrary to Section 334(b) of the *Criminal Code of Canada*;
2. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code of the Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(1) of *Ontario Regulation 799/93*, in that while registered with the College of Nurses of Ontario as a Registered Practical Nurse, you contravened a standard of practice of the profession or failed to meet the standard of practice of the profession in that:
 - a) between September 8, 2021 and December 10, 2021, you misappropriated narcotics from St. Joseph's Healthcare Hamilton;
3. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code of the Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(8) of *Ontario Regulation 799/93*, in that while registered with the College of Nurses of Ontario as a Registered Practical Nurse, you misappropriated property from a patient or workplace, and in particular:

- a) between September 8, 2021 and December 10, 2021, you misappropriated narcotics from St. Joseph's Healthcare Hamilton;
4. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code of the Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(18) of *Ontario Regulation 799/93*, in that while registered with the College of Nurses of Ontario as a Registered Practical Nurse:
- a) you contravened a term, condition or limitation on your certificate of registration, as provided by section 1.5(1)1.(i) of *Ontario Regulation 275/94 of the Nursing Act, 1991*, in that you failed to report findings of guilt arising in any jurisdiction relating to any offence to the College of Nurses of Ontario, as follows:
 - i. on October 31, 2022, in the Ontario Court of Justice, you were found guilty of one count of theft under \$5,000.00, contrary to Section 334(b) of the *Criminal Code of Canada*; and/or
 - b) you contravened a term, condition or limitation on your certificate of registration, as provided by section 1.5(1)1.(ii) of *Ontario Regulation 275/94 of the Nursing Act, 1991*, in that you failed to report charges arising in any jurisdiction relating to any offence to the College of Nurses of Ontario, as follows:
 - i. on or about January 10, 2022, you were charged with the following offences:
 - 1. that on or between the 17th day of August, 2021 and the 9th day of December, 2021, at the City of Hamilton, you did unlawfully steal to wit: Hydromorphone valued at under \$5,000.00, the property of St. Joseph's Healthcare Hamilton, contrary to the provisions of Section 334(b) of the *Criminal Code of Canada*; and/or
 - 2. that on or between the 17th day of August, 2021 and the 9th day of December, 2021, at the City of Hamilton in the said region being the trustee of St. Joseph's Healthcare Hamilton, for your own profit, did convert a secure drug dispense code to a use not authorized by the trust with intent to defraud and in contravention of the trust contrary

to the provisions of Section 336 of the *Criminal Code of Canada*;

5. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code of the Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(19) of *Ontario Regulation 799/93*, in that, in that while registered with the College of Nurses of Ontario as a Registered Practical Nurse, you contravened a provision of the *Nursing Act, 1991*, the *Regulated Health Professions Act, 1991*, or the regulations under either of those Acts, in that:
- a) you contravened section 85.6.1 of the *Health Professions Procedural Code*, in that you failed to report a finding of guilt of an offence to the College of Nurses of Ontario, as follows:
 - i. on October 31, 2022, in the Ontario Court of Justice, you were found guilty of one count of theft under \$5,000.00, contrary to Section 334(b) of the *Criminal Code of Canada*; and/or
 - b) you contravened section 85.6.4 of the *Health Professions Procedural Code*, in that you failed to report being charged with an offence and/or information about any bail condition or other restriction imposed on, or agreed to, in connection with a charge to the College of Nurses of Ontario, as follows:
 - i. on or about January 7, 2022, you gave an undertaking to comply with conditions of release; and/or
 - ii. on or about January 10, 2022, you were charged with the following offences:
 - 1. that on or between the 17th day of August, 2021 and the 9th day of December, 2021, at the City of Hamilton, you did unlawfully steal to wit: Hydromorphone valued at under \$5,000.00, the property of St. Joseph's Healthcare Hamilton, contrary to the provisions of Section 334(b) of the *Criminal Code of Canada*; and/or
 - 2. that on or between the 17th day of August, 2021 and the 9th day of December, 2021, at the City of Hamilton in the said region being the trustee of St. Joseph's Healthcare Hamilton, for your own profit, did convert a secure drug dispense code to a use not authorized by the trust with

intent to defraud and in contravention of the trust contrary to the provisions of Section 336 of the *Criminal Code of Canada*;

6. You have committed an act of professional misconduct as provided by subsection 51(1)(c) of the *Health Professions Procedural Code of the Nursing Act, 1991*, S.O. 1991, c. 32, as amended, and defined in subsection 1(37) of *Ontario Regulation 799/93*, in that while registered with the College of Nurses of Ontario as a Registered Practical Nurse, you engaged in conduct or performed an act, relevant to the practice of nursing, that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional in that:
- a) between September 8, 2021 and December 10, 2021, you misappropriated narcotics from St. Joseph's Healthcare Hamilton;
 - b) on October 31, 2022, in the Ontario Court of Justice, you were found guilty of one count of theft under \$5,000.00, contrary to Section 334(b) of the *Criminal Code of Canada*; and/or
 - c) you failed to report charges, an undertaking to comply, and/or findings of guilt to the College of Nurses of Ontario, as follows:
 - i. on or about January 7, 2022, you gave an undertaking to comply with conditions of release;
 - ii. on or about January 10, 2022, you were charged with the following offences:
 - 1. that on or between the 17th day of August, 2021 and the 9th day of December, 2021, at the City of Hamilton, you did unlawfully steal to wit: Hydromorphone valued at under \$5,000.00, the property of St. Joseph's Healthcare Hamilton, contrary to the provisions of section 334(b) of the *Criminal Code of Canada*; and/or
 - 2. that on or between the 17th day of August, 2021 and the 9th day of December, 2021, at the City of Hamilton in the said region being the trustee of St. Joseph's Healthcare Hamilton, for your own profit, did convert a secure drug dispense code to a use not authorized by the trust with intent to defraud and in contravention of the trust contrary

to the provisions of section 336 of the *Criminal Code of Canada*; and/or

- iii. on October 31, 2022, in the Ontario Court of Justice, you were found guilty of one count of theft under \$5,000.00, contrary to Section 334(b) of the *Criminal Code of Canada*.

The allegations respecting professional misconduct on your part will be heard by a panel of the Discipline Committee of the College of Nurses of Ontario (“CNO”), pursuant to the *Nursing Act, 1991*, S.O. 1991, c.32, as amended, and subsection 38(1) of the *Health Professions Procedural Code*, on **July 10, 11 and 29, 2024 at 0930 hours or as soon after that time as the hearing can be commenced**, via electronic hearing by way of teleconference or videoconference.

The details for participating in the electronic hearing will be provided to you by a Hearings Administrator. If you have not heard from a Hearings Administrator at least 48 hours in advance of the hearing, you should contact the Hearings Administration Team at: Admin-Business.Support-Hearings@cnomail.org to obtain the details for participating in the electronic hearing.

If you believe that holding an electronic hearing rather than an oral hearing is likely to cause you significant prejudice, please communicate in writing the basis for asserting such prejudice to the Hearings Administration Team at the email address listed above. To ensure the claim of prejudice can be considered by the Discipline Committee, any such concerns should be communicated to the Hearings Administration Team as soon as possible, and no later than 21 days in advance of the hearing.

Take notice that at least 48 hours before the electronic hearing is scheduled to commence, you must provide notice to the Hearings Administration Team, at the email address listed above, of the telephone number and email address where you can be reached for the electronic hearing.

If you fail to participate in the electronic hearing in person or by representative, the panel of the Discipline Committee may proceed in your absence and you are thereafter not entitled to any further notice of the proceedings.

Where the panel of the Discipline Committee finds a member has committed an act of professional misconduct, it may make an Order doing any one or more of the following:

1. directing the Registrar to revoke the member's certificate of registration;

2. directing the Registrar to suspend the member's certificate of registration for a specified period of time;
3. directing the Registrar to impose specified terms, conditions and limitations on the member's certificate of registration for a specified or indefinite period of time;
4. requiring the member to appear before the panel to be reprimanded;
5. requiring the member to pay a fine of not more than \$35,000.00 to the Minister of Finance;
6. requiring the member to reimburse CNO for funding provided for a program of therapy and counselling for a person if the act of professional misconduct was the sexual abuse of that person; and
7. requiring the member to post security acceptable to CNO to guarantee the payment of any amounts the member may be required to reimburse CNO for a program of therapy and counselling for a person who was sexually abused by the member.

Furthermore, the panel may suspend the effect of its Order for a specified period of time and on specified conditions and where it makes an Order under paragraph 2 or 3 above, it may specify criteria to be satisfied for the removal of a suspension or the removal of terms, conditions and limitations imposed by the Order on the member's certificate of registration.

Where a panel of the Discipline Committee finds a member has committed an act of professional misconduct, it may make an Order requiring the member to pay all or part of the following costs and expenses:

1. CNO's legal costs and expenses;
2. CNO's costs and expenses incurred in investigating the matter; and
3. CNO's costs and expenses incurred in conducting the hearing.

CNO intends to introduce as business records, under section 35 of the *Evidence Act*, any writings or records that were made in the usual and ordinary course of business. Without limiting the generality of the foregoing, and where applicable, CNO intends to introduce as business records medical and hospital charts.
